FIG. 6 is a top plan view thereof.

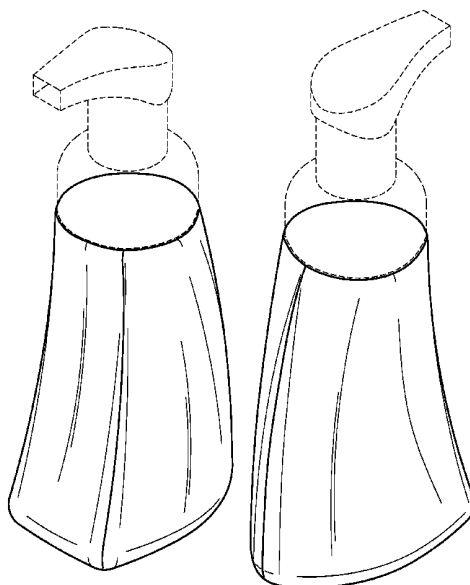
FIG. 7 is a back elevational view of the claimed design.

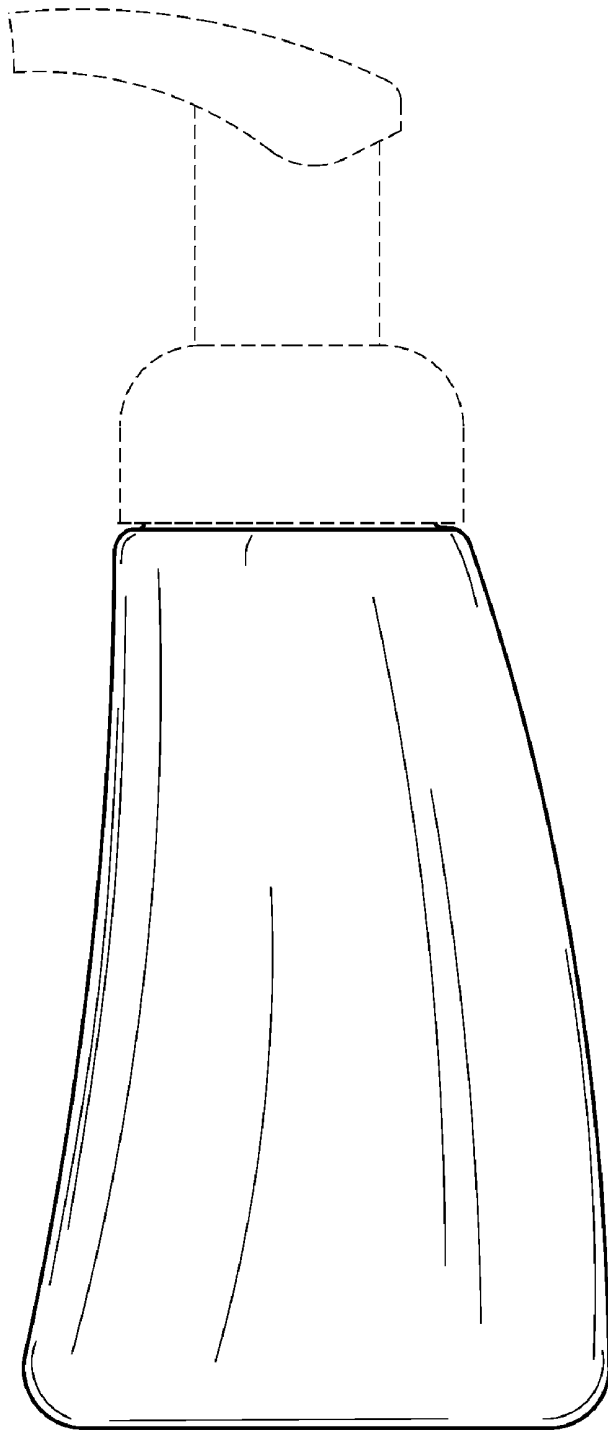

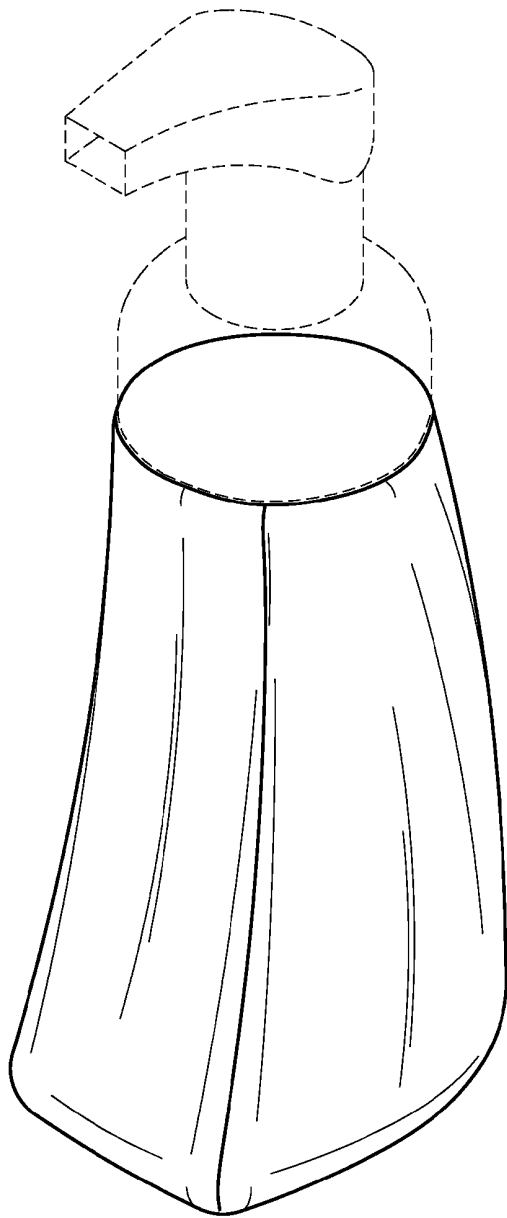

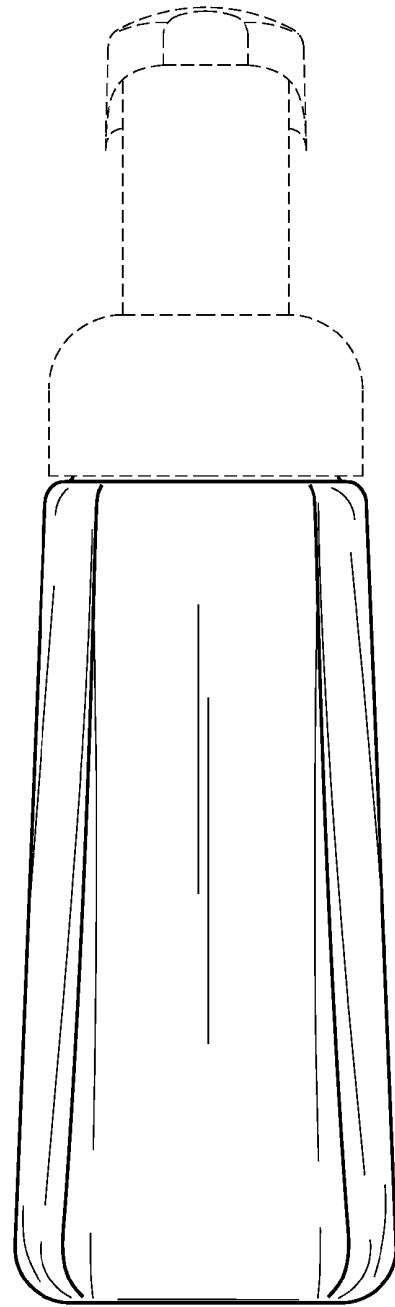

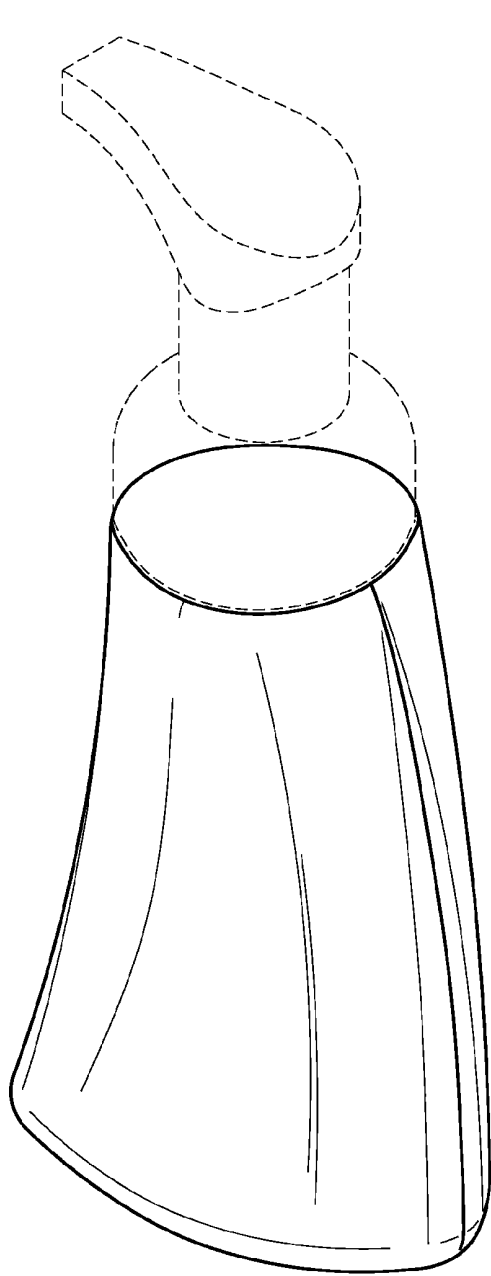

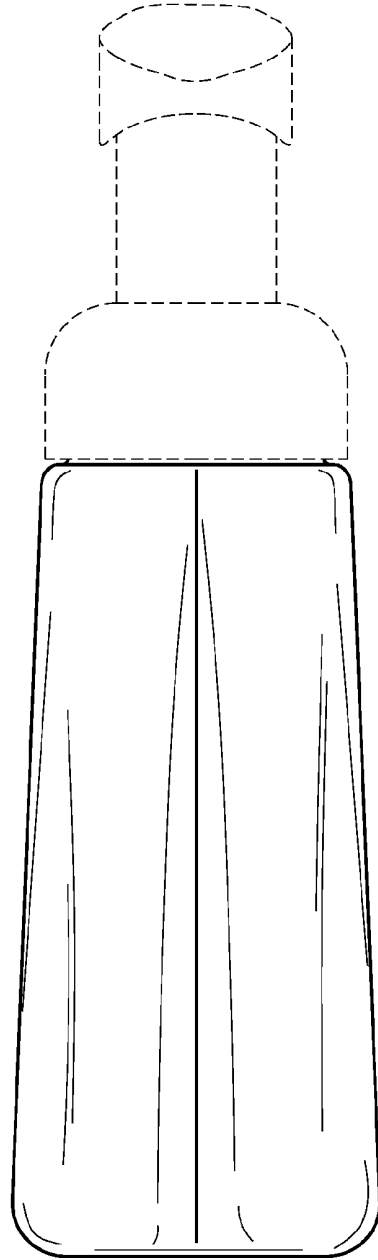

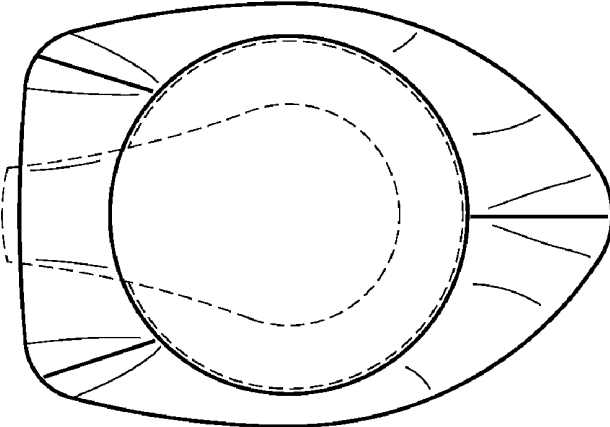

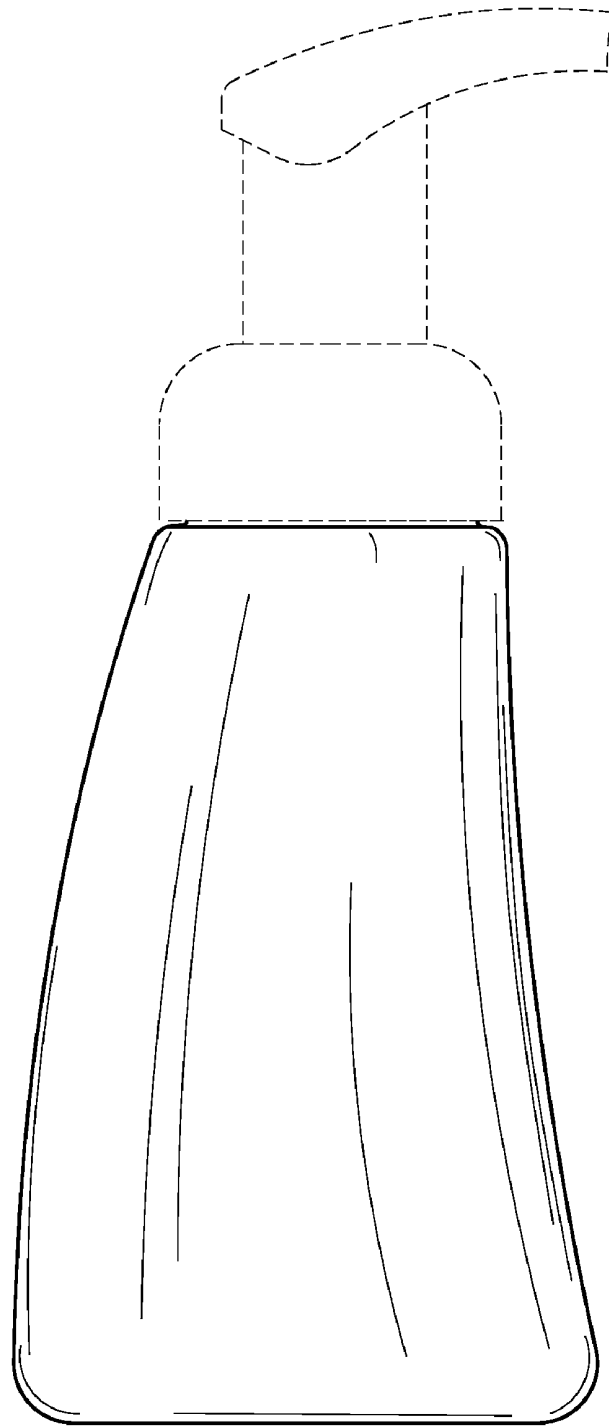

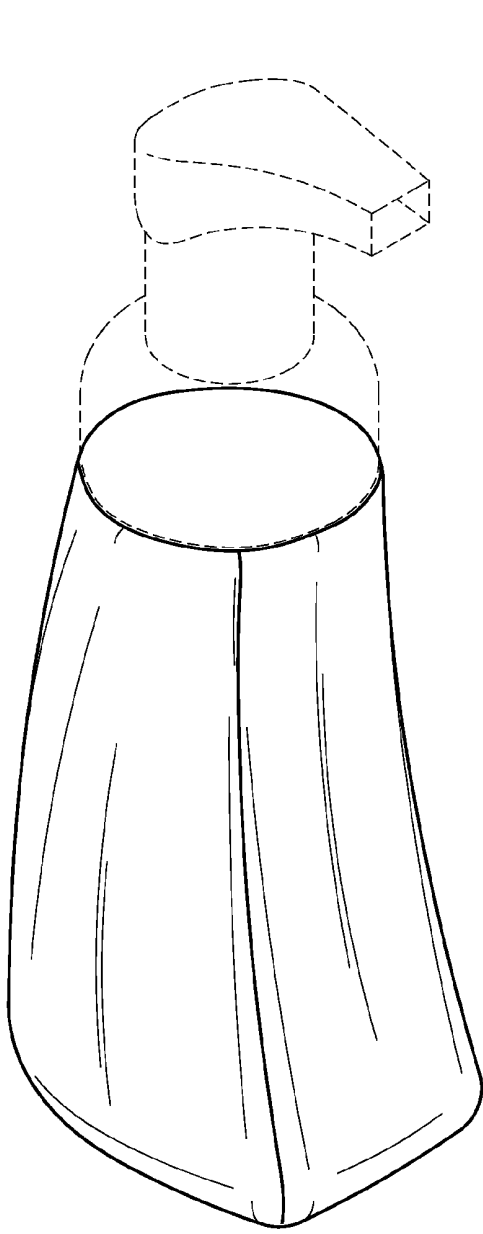

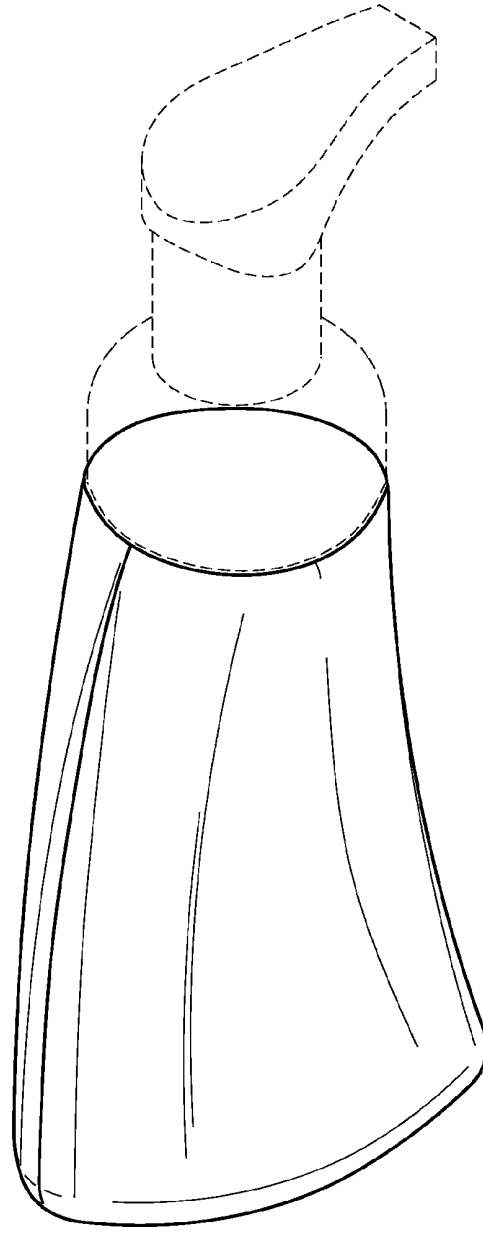
