FIG. 7 is a heel side elevation view thereof.

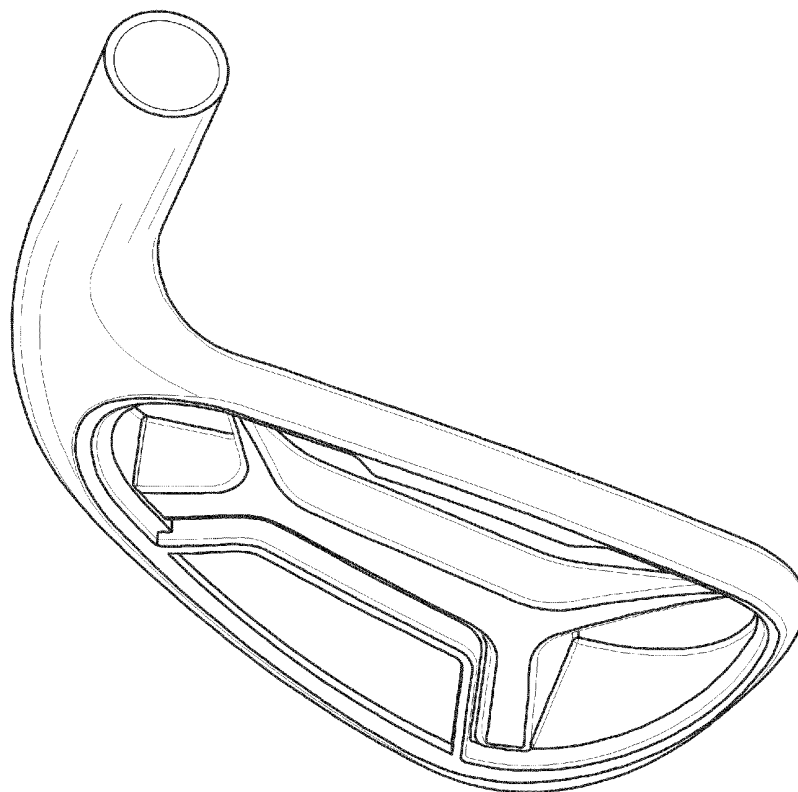

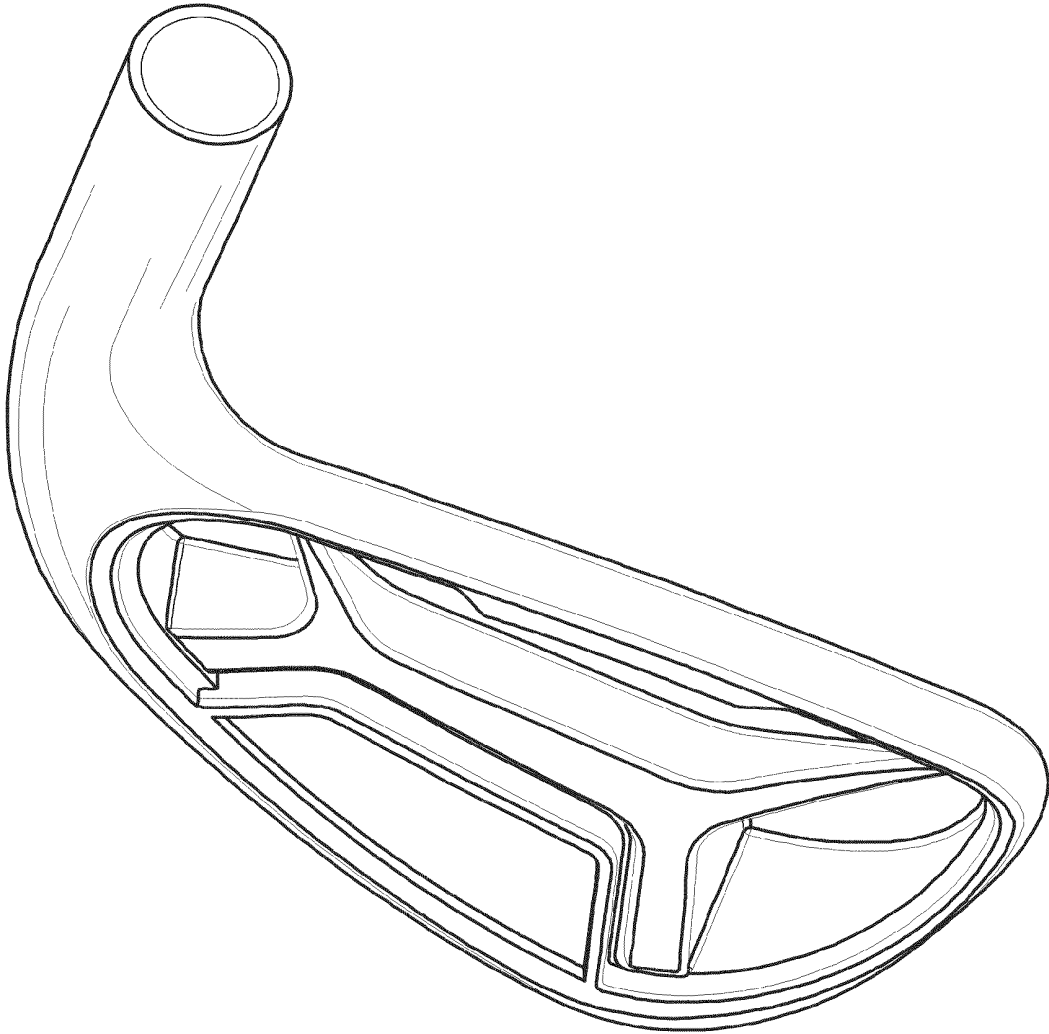

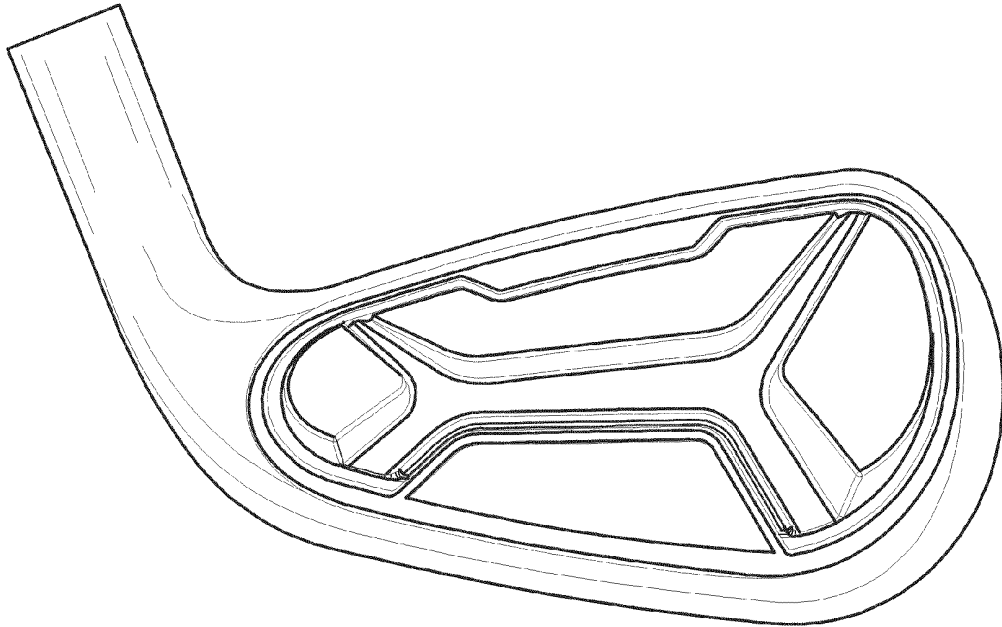

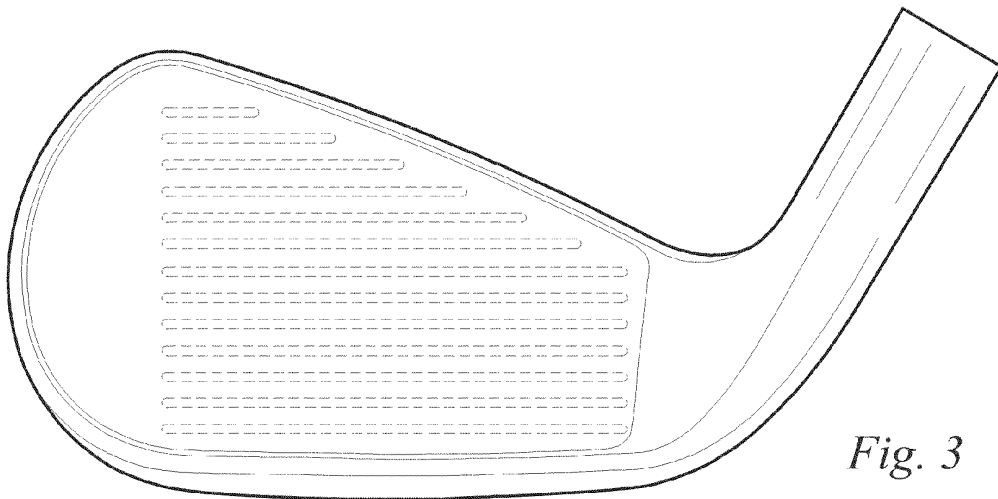




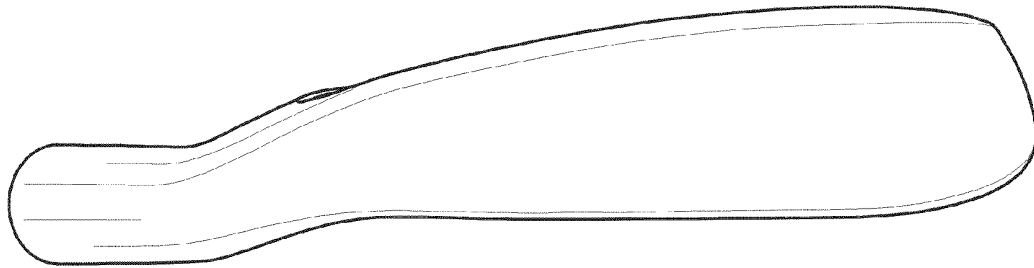

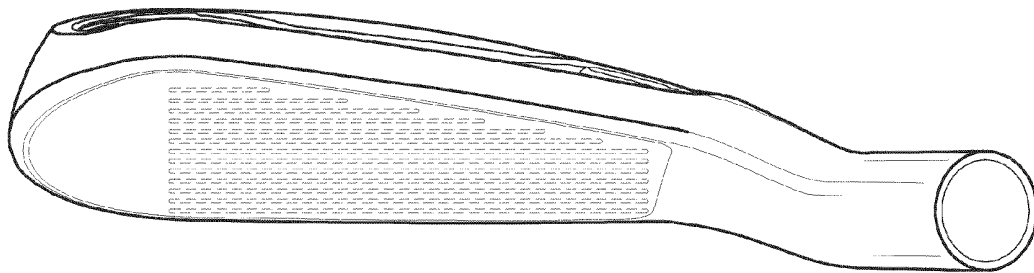
