We claim the ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, rear, left side perspective view of a bottle showing our new design;

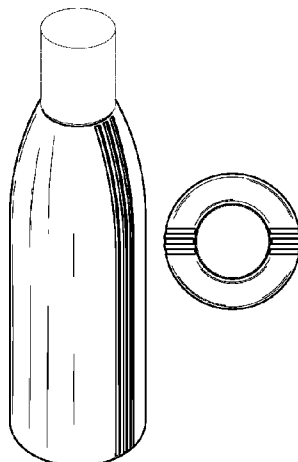
FIG. 2 is a front elevational view thereof;

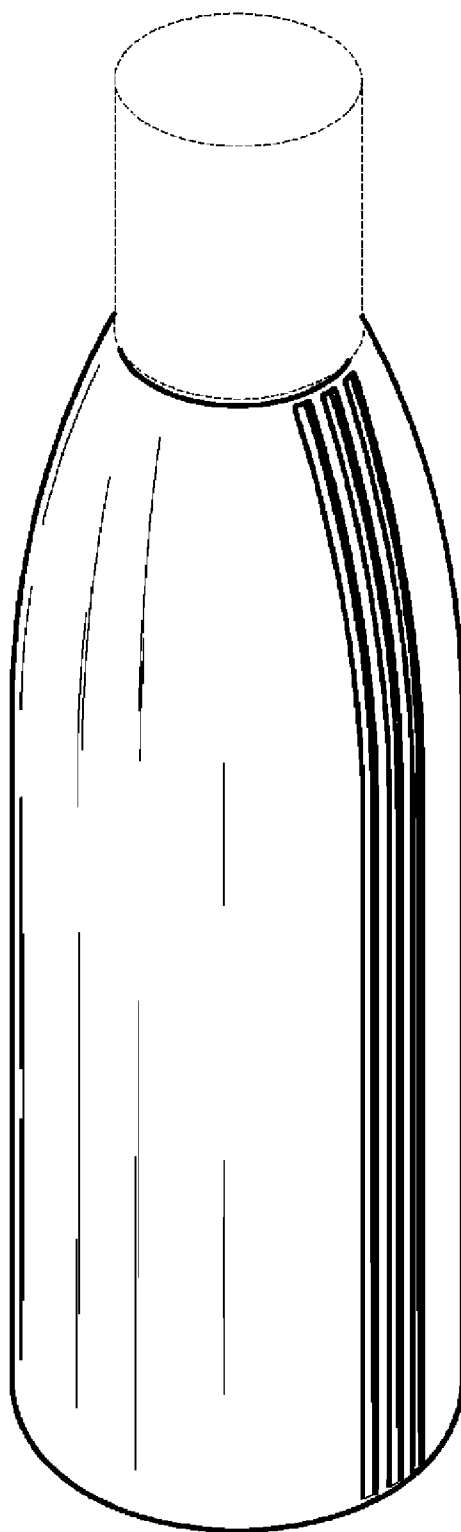

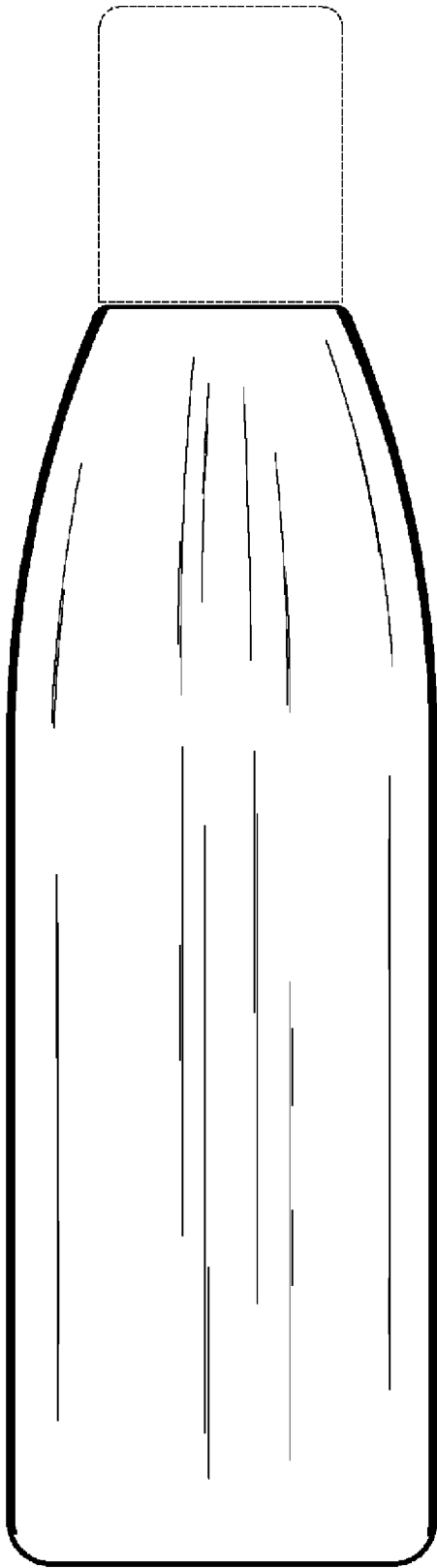

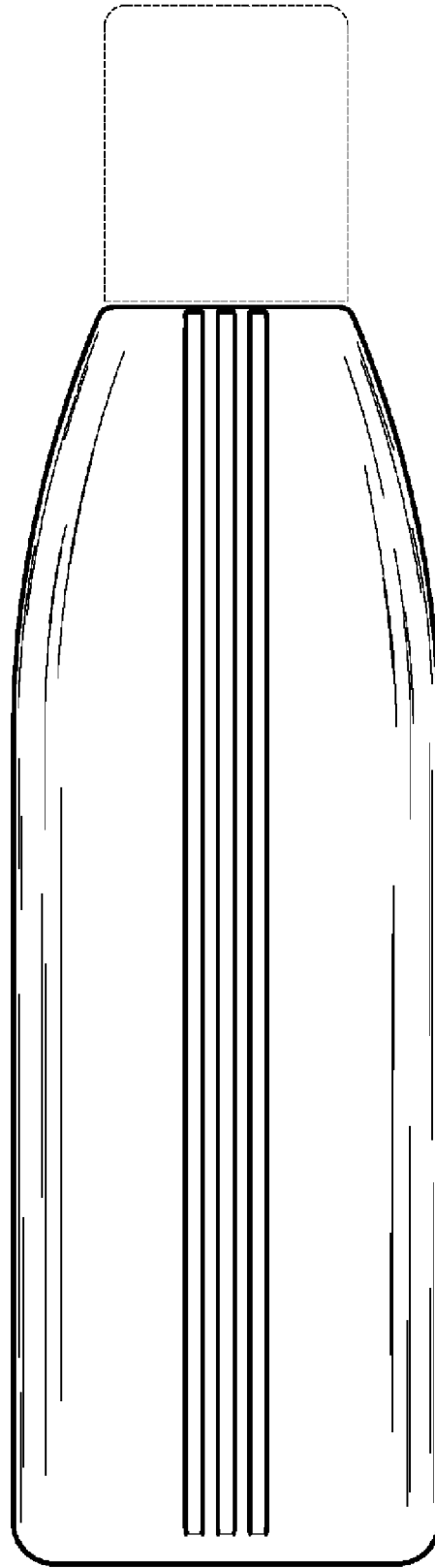

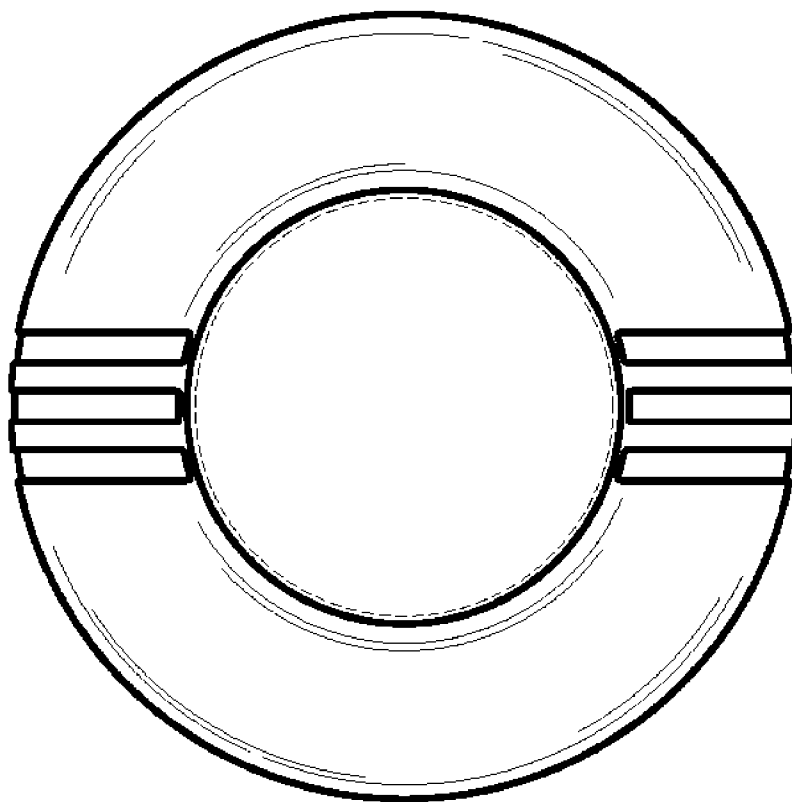
